The attention of all the RJDSEs / DEOs in the State is invited to the subject
cited, and they are requested to follow the following guidelines scrupulously.

- In continuation of the instructions issued in the Video conference
on 27-01-2009, it is hereby clarified that all the DEOs are requested
to follow the pattern of the seniority list which was prepared for the 2005
promotion counseling. It is learnt that there is no uniformity in the districts.
As time is very short it has been decided to adopt the previous counseling
procedure.
- Further with regard to the promotions to the cadre of HM Gr. II the
following procedure be adopted by all the RJDSEs
 - I. A combined seniority list of eligible SAs for the post of HMs in the
zone has to be prepared both for government and ZP School teachers
duly following the Roster points as was done in 2005
 - II. Then posting can be given to Government School Assistants in any
one of the vacancy of the Head Masters in that Zone.
 - III. If a teacher belonging to ZP school is in the promotion list and
there is no vacancy in that particular district where he is working, then
his case has to be deffered for future vacancy in that management.
However, if the next person to be promoted is a teacher belonging to
Government Sector he can be promoted to any one of the vacancies
available in that zone of Government Schools
- With regard to the promotion of LFL HMs as HM Gr. II in High
Schools, only the teachers with requisite qualifications are to be considered.
LFL HM with Inter and TTC only cannot be considered.
