Attention of all project Officers of ITDAs, Deputy Directors of ITDAs and District Tribal Welfare Officers is drawn to the subject and reference cited.


2. In the ref 4th cited Project Officer, Utnoor has requested to clarify whether the promotion of PGHMs can be given according to seniority duly following the rule of reservation in promotions in favor of SC, STs as per G.O. 5, dt. 14-2-2003 and GO.2, dt. 9-1-2004 OR 100 % reservation in promotion to the posts of PGHMs can be given to the School Assistants of Scheduled Tribes alone as the posts of Teachers in Schedule areas has been reserved for local STs only while recruiting initially in terms of GOs 275, dt. 15-11-1986 and G.O.3, dt. 10-1-2000.

3. In this regard, it is to inform that as clarified by Govt. vide reference 1st cited also (Copy enclosed) the 100% reservation in scheduled areas is applicable only for direct recruitment at the initial appointment only, but not for promotion. The promotion can be made as per rule of reservation in terms of G.O.Ms.No.5, SW (Ser.I-2) Dept. dt. 14-2-03 (Copy enclosed) and G.O.Ms.No.2 SW (Ser.)Dept. dt. 2-1-04 (Copy enclosed) in respect of in Scheduled areas also.

4. Therefore all the POs/DDs/DTWOs are directed to adhere to the above instructions and also follow the counseling guidelines in terms of G.O.Ms.No.53 SW(TW.Ser.I) Dept., dt. 28-6-05.
