The under mentioned officers are informed that the updation of U-DISE for year 2015-16 through online is completed in the State. A. quick analysis of the data revealed that there is a significant difference in enrolment of children in the U-DISE as well as Child info data of 2014-15 to 2015-16, with regard to some schools in respective districts.

It is reported that the U-DISE data entry for New Schools and Intermediate Colleges will be completed by 20th January 2016. The oracle Data dumps will be provided to the districts by 22nd January 2016. The Scholl Report Card signing should be completed by then.

It is to be kept in view that the verified and validated U-DISE/Child info data 2015-16 will be the basis for all projects — SSA, RMSA, MDM, etc. It will be the basis for assessments of Andhra Pradesh State performance on all Education Indicators, Including Gross Enrolment Ratio, Net Enrolment Ratio, Teacher Pupil Ration, etc., hence it must be ensured that 100% data entry is completed and validated before submitting to Govt. of India.

The District Educational Officers and Project Officers, Sarva Sikshaabhiyan are also Instructed to constitute district level teams to verity the differences at the field level. The District level teams for field level verification will be comprised of the Nodal Officers for U-DISE – Child info (ASO/APO), few Head Masters, MEOs, Dy.Eos, Ads, etc. The district level teams shall share the details of the physical verification undertaken by them with the State level Observers along with any other problems of U-DISE and Child info relating to the process of data collection / updation encountered in the district, suggestions for improved methods/processes, etc., and.

The State Level teams are constituted to visit the assigned district and conduct physical verification in 10-20 schools in the district with reference to the school records i.e., Admission / Attendance / Child info etc.

The State Level team is further informed that it is observed that 8% to 10% of children don't have the Aadhaar ID. For this purpose the District Level Team / State Level Team are requested to ensure that all such children data is seeded with the Aadhaar by conducting a special drive in consultation with the District Collector.
